

## 成衣製品附表

本附表轉載自香港法例第 318 章工業訓練（製衣業）條例成衣製品附表。任何在表內所指明並在香港製造的衣着製品，在出口時均須繳付製衣業訓練徵款。本附表是為方便出口商參考而設，並非進出口貨物分類表（協調制度）的一部分。除另有規定外，表內所列的港貨協制章、項目或分項，均包括其屬下所有條目。

## Schedule of Clothing Items

This Schedule is reproduced from the Schedule of Clothing Items to the Industrial Training (Clothing Industry) Ordinance, Chapter 318 of the Laws of Hong Kong. Any item of apparel which is specified in the Schedule and manufactured in Hong Kong is subject to a Clothing Industry Training Levy on export. This Schedule is appended for the convenient reference of exporters and does not form part of the Imports and Exports Classification List (Harmonized System). Where a Chapter, Heading or Subheading of the HK HS is quoted, all the items under it are included unless otherwise specified.
